Effective Date: 1 January 2018. "Federal Grain Inspection Service (FGIS) must approve all fees for official services and official agencies will assess only fees appearing on their current approved fee schedule.

Hourly rates will be charged in quarter hour increments. All overtime, Sunday, and holiday rates will be assessed in addition to unit fees. Overtime will be assessed for all work performed outside regular hours. A minimum call out charge of four (4) hours will be assessed at applicable hourly rate outside regular business hours.

Holidays: New Year's Eve, New Year's Day, President's Day, Good Friday, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Christmas Eve and Christmas Day. Holidays which fall on Saturday will be celebrated on the preceding Friday, those which fall on Sunday will be celebrated on the following Monday.

On call charges: On call charges occur when an applicant requests personnel to be available outside regular business hours. Elevator must establish a start / notification time for agency personnel to be available for work. If the work is not performed at this time and personnel are requested to continue on call waiting for a return notification of work, a charge of two (2) hours at the applicable rate of pay will be charged to the requesting facility.



Travel time will be charged for all travel during regular business hours. Applicable hourly rate per employee, per trip, in quarter hour increments or fraction of based on mileage traveled.

Mileage Rate: The IRS standard mileage rate will be assessed for all services performed basis portal to portal. Any change to the mileage rate is effective when the IRS changes their standard mileage rate. Mileage will be prorated when more than one elevator per trip.

Official Service Fees: Includes sampling charges except as indicated and all USDA / GIPSA user fees.

On-site inspection service: Applicable hourly rate per person plus unit fee if personnel are available. Elevator will be charged at the hourly rate of one (1) railcar per quarter (1/4) hour of standby time.

Service charges for unpaid balances in the amount of 1.5% per month will be assessed. This fee would be effective on all balances not paid or postmarked by the 25th of the month following the invoice date.
