SCHEDULE OF FEES AND CHARGES

Effective Date: January 1, 2013, Federal Grain Inspection Service (FGIS) must approve all fees for official services and official agencies will assess only those fees appearing on their current approved fee schedule. Unit fees include FGIS supervision fees.

Regular Hours: 7:30 a.m. to 4:30 p.m. Monday thru Friday **EXCEPT** holidays. Part-time sampling hours will be adjusted to applicant hours not to exceed 8 hours per day.

Regular, Standby, Travel, Overtime, Sunday, & Holiday Hourly Rates: Assessed in half-hour increments.

Hastings Grain Inspection reserves the right to determine the number of inspection personnel to properly service the customer. Call in or back to work will be assessed a 4 hour minimum at the applicable hourly rate.

Mileage Rate: IRS standard rate will be assessed for actual miles traveled outside Grand Island and Hastings city limits by full-time or part-time personnel. Any change to the mileage rate is effective when the IRS changes their standard mileage rate.

Intermittent Onsite Lab Service: Carrier or sample fee, applicable travel and mileage plus overnight lodging cost when required to remain away from inspection point.

AMA FEE SCHEDULE

Services Performed under Agricultural Marketing Act of 1946
(Fees include GIPSA-FGIS user fee)

Effective Date

January 1, 2013

Regular Hours

Monday through Friday from 7:30 a.m. to 4:30 p.m. All hourly rates assessed in half-hour increments per individual necessary to perform the service and a minimum of 2 hours per person will be assessed.

Regular Hourly Rate

\$30.00

Overtime Hourly Rate

One and one-half times regular hourly rate. Applies to Saturday and other than regular hours. Minimum of 4 hours per person is assessed for Saturday, Sunday, and holidays worked.

Sunday and Holiday Hourly Rate

Double the regular hourly rate. Holidays include; New Year's Day, Memorial Day, July 4th, Labor Day, Thanksgiving, and Christmas.

Mileage

The IRS standard mileage rate will be assessed per mile actual miles traveled. Any change to the mileage rate is effective when the IRS changes their standard mileage rate. Mileage and travel time will be prorated when it is possible.

Travel

Airfare and other related expenses will be assessed at actual cost. Per Diem will be assessed at \$25.00 per day.

Inspection Services

Sampling, mileage, postage, and delivery charges are in addition to unit fees listed. Standby and travel hours will be assessed at applicable hourly rates. All requests for service will be honored as soon as possible on a first call-first service basis. All requests for service should be ordered by 2:00 p.m. the preceding day or the preceding Friday for the weekend.
