OFFICIAL INSPECTION FEES

EFFECTIVE DATE: November 9, 2009. "Federal Grain Inspection Service (FGIS) must approve all fees for official services and OAs will assess only those fees appearing on their current approved fee schedule."

REGULAR HOURS: 7:00 a.m. to 5:00 p.m. Monday through Friday, except Holidays.

REGULAR OVERTIME AND HOLIDAY CHARGES

5:00 p.m. – 11:00 p.m., plus the unit rate.....\$13.00/Hour/Person
11:00 p.m. – 7:00 a.m., plus the unit rate.....\$19.50/Hour/Person
SATURDAY, plus the unit rate.....\$19.50/Hour/Person
SUNDAY and HOLIDAYS, plus the unit rate.....\$26.00/Hour/Person
Holidays shall include the following: Easter, Memorial Day, July 4th, Labor Day, Thanksgiving, Christmas Eve (after 12:00 p.m.), Christmas Day, New Years Eve (after 12:00 p.m.) and New Years Day. A minimum of 4 hours will be charged when working past 11:00 p.m., regardless of finishing time; and for Saturday, Sunday or Holiday work.


TRAVEL TIME: Applicable Hourly Rate

MILEAGE RATE: The IRS standard mileage rate will be assessed per mile for actual miles traveled (prorated when possible). Any change to the mileage rate is effective when the IRS changes its standard mileage rate.

STANDY TIME: When inspection personnel are ready to perform the service requested, but are unable to perform the service because of a delay by the applicant for any reason, the applicable hourly rates will be charged.

ON-SITE LAB INSPECTION SERVICES

When requested to provide inspection services at an On-Site Lab, additional fees are assessed as follows:
On-site Lab fee (plus hourly personnel fee)\$13.00/Hour loading time
7:00 a.m. – 5:00 p.m.....No Personnel fee
5:00 p.m. – 11:00 p.m.....\$13.00/Hour/Person
11:00 p.m. – 7:00 a.m.....\$19.50/Hour/Person
(A minimum of 4 hours will be charged when working past 11:00 p.m., regardless of finishing time.)

NOTES

- Any customer anticipating service should contact the agency for scheduling by 4:00 p.m., the prior day. All late requests will be honored as soon as licensed personnel are available.
- On-site Lab inspection personnel are available on a "first come, first served" basis; if NEIGI does not have inspectors available to serve an on-site lab, a sampler can be provided at the lab, with the samples inspected as soon as licensed personnel are available.
- Personnel working at on-site labs are limited to 12 hours shifts.
- Service requests not covered by the above fees will be performed at the applicable hourly rate.
- Hourly rates billed in quarter-hour increments.
- A 2% late charge will be added to all accounts not received within 21 days of the billing date.
