SCHEDULE OF FEES AND CHARGES

EFFECTIVE DATE: July 1, 2012 The Federal Grain Inspection Service (FGIS) must approve all fees for official services and Official Agencies will assess only those fees appearing on their current approved fee schedule.

REGULAR HOURS: 7:00 AM to 4:00 PM Monday through Friday except holidays.

OVERTIME HOURS: One and one-half the regular rate for work performed on Saturday and other than regular hours.

SUNDAY and HOLIDAY HOURS: Two times the regular rate. Holidays are: New Years Day, Presidents Day, Memorial Day, 4th of July, Labor Day, Thanksgiving Day, Christmas Day, and after 11:00 AM on Christmas Eve and New Years Eve.

REGULAR HOURLY RATES: Technician \$20.00 Inspector \$20.00

Rates are assessed in quarter hour increments. SCI reserves the right to determine the number of personnel to properly provide the service requested.

STANDBY RATES: Will be charged at the applicable hourly rate for delays not caused by the agency.

MILEAGE RATE: The IRS standard mileage rate will be assessed for all services performed basis service point's city limits. Any change to the mileage rate is effective when the IRS changes their standard rate. Mileage may be prorated when more than one point is provided service per trip.

OFFICIAL INSPECTION SERVICES: Mileage and Freight charges are in addition to unit fees listed below. Standby and Travel hours will be assessed at applicable hourly rates.

EXTENDED LOAD TIME FEE: On-Site minimum of seven (7) railcars per hour average for the train. Amounts less than seven (7) railcars per hour will be billed at the current railcar rate. Maximum charge \$500.00 per train.
