EFFECTIVE: July 1, 2016

"Federal Grain Inspection Service (FGIS) must approve all fees for official services and OAs will assess only those fees appearing on their current approved fee schedule."

This revised schedule of fees and charges includes FGIS administrative Fees. It supersedes all fee schedules previously issued by this Agency.

ESTABLISHED INSPECTION POINTS: Mobile

REGULAR HOURS:

7:00 a.m. to 5:00 p.m. Monday through Friday, except holidays and when a shift is scheduled in advance (excluding Saturday and Sunday) by an applicant for truck, railcar, and barge inspection and weighing. Regular hours 7:00 AM. to 5:00 P.M. Monday through Friday subject to meeting elevator requirement, not to exceed 8 hours per day. The \$30.00 hourly rate will apply if requested services are not identified by a unit fee.

OVERTIME: **\$35.00 Per Individual Hour**

A four-hour minimum per individual when called out on overtime EXCEPT; One hour before or continuation of a regular workday.

HOLIDAY:

Holidays include New Years' Day, Veterans' Day, July 4th, Labor Day, Thanksgiving Day, Christmas Day, National Memorial Day, Mardi Gras, Confederate Memorial Day, Martin Luther King's birthday, Columbus Day, Jefferson Davis's birthday, and George Washington's birthday.

Cancellation of Shift Work - \$30.00 per each man hour if not cancelled during workday prior to schedule.

Charges are assessed in half-hour increments in addition to carrier and sample fee.



TRAVEL TIME CHARGE: \$30.00 Per Individual Hour

MILEAGE CHARGE: "The IRS standard mileage rate will be assessed per actual miles traveled plus travel time. Any change to the mileage rate is effective when the IRS changes their standard mileage rate. Mileage and travel time will be prorated when it is possible."

OFFICIAL SERVICES: Official Services not covered in this schedule will be charged at the appropriate hourly rate.

7:00 a.m. to 3:30 p.m. Monday through Friday, except holidays. Not to exceed 8 hours per day. The \$30.00 hourly rate will apply if requested services are not identified by a unit fee.

OVERTIME: \$35.00 per Individual Hour

A four-hour minimum per individual when called out on overtime.
