EFFECTIVE DATE: December 1, 2017 Federal Grain Inspection Service (FGIS) must approve all fees for official services and Official Agencies (OA'S) will assess only those fees appearing on their current approved fee schedule.

All hourly rates will be assessed in quarter hour increments. Travel and standby time will be assessed at the applicable hourly rate.

MINIMUM FEE: A 4-hour minimum call out fee will be assessed at the applicable hourly rate. Travel time will not be charged when the minimum fee applies.

MILEAGE: The IRS standard mileage rate will be assessed per mile for actual miles traveled. Any change to the mileage rate is effective when the IRS changes their standard mileage rate. Mileage and travel time will be prorated when possible.

PER DIEM: \$15.00 per day per individual, plus lodging expense, when required to stay overnight away from the main office location.

ON SITE LAB INSPECTIONS: Revenue generated during normal office hours must equal \$17.35 per hour, per person. Saturday and other than normal office hours revenue must equal \$26.00 per hour Per person. Sunday and holiday revenue must equal \$34.70 per hour per person.

Requests for services not covered by the above fees will be performed at the applicable hourly rate stated herein. Mileage and travel time will be assessed.

LATE PAYMENT CHARGE: A late payment charge of two percent (2%) will be assessed on any payment not received ten (10) days after the billing date.

PERSONNEL SAFETY: At times the need for two people to sample hopper cars may result in increased costs to the applicant. When cars are to be probed and a man is



provided by the elevator for safety, one sampler will perform the requested service. Otherwise, two samplers will be required.

OFFICIAL SERVICES: Sampling time, standby time, mileage and travel time will be assessed at the applicable hourly rate for all services listed below when applicable.
