## Fee Schedule

**Effective Date:** October 1, 2012 **Federal Grain Inspection Service (FGIS) must approve all fees for official services and OAs will assess only those fees appearing on their current approved fee schedule.** State and local tax will be added as needed.

**Regular Hours and Hourly Rate:** 7:00 a.m. to 4:00 p.m. (first 8 hours within regular business hours), Monday through Friday except Holidays. All hourly charges will be assessed in quarter-hour increments, per individual necessary to perform the service outside the Des Moines and Iowa Falls offices. Hourly rates will be charged at one and one-half times the applicable hourly rate for onsite service and sampling if the following minimums are not met: an average of four railcars per hour.

Sampler: \$16.00      Inspector/Technician: \$20.00

**Onsite Lab Staffing:** Applicable hourly rate charged per individual as necessary to perform the service, minimum of one inspector and one technician. All labor will be charged at \$20.00 per hour, per person and is subject to overtime, holiday/Sunday rates. Basis: Depart/arrive Des Moines/Iowa Falls lab, plus mileage and inspection fees.

**Overtime Hourly Rate:** One and one-half times the regular hourly rate assessed in quarter-hour increments in addition to unit grading fees.

**Sunday and Holiday Hourly Rate:** Double the regular hourly rate assessed in quarter-hour increments in addition to unit grading fees. Holidays include New Years Day, Memorial Day, Independence Day, Labor Day, Thanksgiving, and Christmas.

**Callout Time:** 4-Hour minimum callout time will apply weekend and holidays. A minimum of 4 hours will be charged if not directly preceding or following regular hours.

**Standby/Travel:** Assessed per individual at applicable hourly charges including delays caused by the applicant.

**Mileage Fees:** The IRS standard mileage rate will be accessed for all services performed basis portal to portal. Any change to the mileage rate is effective when the IRS changes their standard mileage rate.

**Official Services:** Includes sampling only as indicated.



Schedule C – Fees for FGIS supervision of official inspection and weighing service performed by designated agencies in the United States. The supervision fee is charged at \$0.011 per metric ton inspected and/or weighed.
