EFFECTIVE DATE: FEBRUARY 1, 2013. This fee schedule supersedes all other fee schedules issued by this agency.

REGULAR HOURS AND HOURLY RATES: 7:00 A.M. to 3:30 P.M. Monday through Friday except Holidays.

Hourly rates will be assessed in quarter-hour increments. Overtime and holiday hourly rates will be assessed in addition to other fees.

HOLIDAYS: Holidays include New Years, Easter, Memorial Day, Independence Day, Labor Day, Thanksgiving, and Christmas.

TRIP CHARGE: The IRS standard mileage rate will be assessed per mile, for actual miles traveled. Any change to the mileage rate becomes effective when the IRS changes their standard mileage rate. Travel time will be assessed at the applicable hourly rate.

OFFICIAL SERVICES: Includes sampling EXCEPT where indicated. Fees include FGIS supervision fees. Overtime fees will be assessed at one and a half the inspection fee when sampling is included in the unit fee.
