GRAIN INSPECTION FEES AND CHARGES FOR ARIZONA

Effective Date: May 1, 2018

Federal Grain Inspection Service (FGIS) must approve all fees for official services and official agencies will assess only those fees appearing on their current approved fee schedule. FGIS user fees included.

REGULAR HOURS: 7:30 am to 4:00 pm Monday through Friday except holidays. All other weekly hours, and Saturday will be considered overtime. Sunday and Holidays (Holidays include New Year’s Day, Memorial Day, July 4th, Labor Day, Thanksgiving Day, and Christmas Day) will be considered double time.

HOURLY RATES: \$29.00 per hour per individual during regularly scheduled hours and \$43.50 per individual during overtime hours, assessed in quarter-hour increments. Overtime and double time will be assessed in addition to unit fees with a four-hour minimum for service performed on Saturday, Sunday, or Holidays. Travel time will be assessed at the applicable hourly rate for service with a one-hour minimum charge. If a holiday falls on Saturday, the previous Friday is a holiday. If a holiday falls on Sunday, the following Monday is a holiday.

MILEAGE FEES: The IRS standard mileage rate will be assessed per mile for actual miles traveled. Any change to the mileage rate is effective when the IRS changes their standard mileage rate.

OFFICIAL SERVICES: Includes sampling EXCEPT as indicated. Export tonnage fees included.

AMA INSPECTION FEES AND CHARGES FOR ARIZONA

Effective Date: April 1, 2018
