## OFFICIAL FEE SCHEDULE

**Effective Date:** January 8, 2018. This fee schedule supersedes all other fee schedules issued by this office. Federal Grain Inspection Service (FGIS) must approve all fees for official services and OA's will assess only those fees appearing on their current approved fee schedule. FGIS user fees included in Container and AMA Fees only.

### Hours:

7:00 a.m. to 3:00 p.m. Monday through Friday excluding holidays. Time may be prorated when possible. **All requests for service will be honored on a first call first service basis.**

**Regular Hourly Rates:** (4-hour minimum applies unless stated otherwise)

**Sampler, Technician, Weigher, Other & Cancellation:** \$19.24 per hour.

**Inspector Rate:** \$26.00 per hour.

All services during regular hours must be cancelled a minimum of 6 hours prior to start, otherwise the 4 hour minimum charge will apply. All hours are per person and assessed in ¼ hour increments. ANY cancellations made during non-regular hours will have applicable minimum charge applied.

**Stand-by Rate:** Any stand-by time in excess of one hour will have an additional \$5.00 per hour added to the appropriate hourly rate.

**On-Call:** On call charges will be applied for requests to hold personnel outside regular business hours. Elevator must establish a start time by 3:00 pm regular business hours. If work is not performed at established time there will be a 4 hour minimum charge, at applicable hourly rate, for each employee that was held for that service.

**Overtime Hourly Rate:** (4-Hour minimum applies to ALL sampling) One and one half (1 ½) times applicable hourly rate applies to all hours outside regular hours and Saturday. (Unless Holiday rate applies.)

**Holiday & Sunday Hourly Rate:** (4-Hour minimum applies to ALL sampling) Two times applicable hourly rate applies to all hours worked on a holiday and Sunday.

**Holidays Include:** New Year's Day, Memorial Day, Independence Day, Labor Day, Good Friday, Thanksgiving Day, Presidents Day, Christmas Day. Holidays which fall on Saturday will be observed on preceding Friday; those which fall on Sunday will be observed on following Monday.

**Mileage Fees:** Mileage will be assessed at a rate of less than or equal to the IRS standard mileage rate and will be prorated when possible.

**Travel Time:** Will be charged at the applicable hourly rate and prorated when possible.

**Sample Pick-up/delivery:** Applicant will be charged appropriate hourly rate and mileage. (Prorated where applicable).

**Minimum Fee(s):** Container, Rail & Truck sampling request must average a minimum of 2 units sampled per hour otherwise an additional \$10.25 will be applied per hour. Time for averaging will be calculated from IOGI office until returning back to IOGI office.

Plastic Seals (per seal) ..... \$1.25  
Cable Seals (per seal) ..... \$2.00

- A picture of every Railcar ID and each seal is taken and stored at IOGI for 30 days for cable seals.
- An extra person will be sent out solely to take pictures and charged at the Additional Labor Rate if cable seals are needed.
- It will be the responsibility of the applicant to notify IOGI when cable seals are needed.

IOGI is not responsible for the plastic/cable seals after the railcar leaves the applicants property. It will be the applicants' responsibility to confirm all seals have been applied by IOGI to their satisfaction.

**Mail Charges:** Applicant requests samples to be mailed – actual charges (plus special handling fee)

All on-site labs will be built, maintained and equipped by the applicant.

IOGI will not guarantee the availability of an inspector for on-site grading unless there is a minimum of 100 cars being loaded in a 24 hour period. If an inspector is available we will provide one at the applicable rates.

Official Commercial Inspection Services are available upon request.

Official services not covered by above fees will be charged at the appropriate hourly and mileage rate.

**Finance Charge:** 1 1/2% per month after 30 days from statement date.

(FOR PROCESSED COMMODITIES)

**Effective Date:** March 1,2017

**Regular Hours:** 7:00 am - 3:00 pm, Monday through Friday excluding holidays  
Time can be prorated when applicable but it is not to exceed 8 hours per day.

**Regular Hourly rate:** \$19.75 per hour, in 1/4 hour increments. (4 hour min. applies).

**Overtime Hourly rate:** 1 1/2 times regular hourly rate applies to all non-regular hours and Saturday (4 hour min. applies).

**Sunday & Holiday rate:** 2 times regular hourly rate applies to all hours worked on Sunday and holidays (4 hour min. applies).

**Holidays include:** New Year's Day, Good Friday, Memorial Day, Independence Day, Labor Day, Presidents Day, Thanksgiving Day and Christmas Day. Holidays which fall on Sat. will be observed on preceding Fri. those which fall on Sun. will be observed on following Mon.

**Stand-by Rate:** Any stand-by time in excess of one hour will have an additional \$5.00 per hour added to the appropriate hourly rate.

**On-Call:** There will be a 4 hour minimum charge, at the applicable hourly rate, per person to hold employees for service.

**Mileage Fees:** Mileage will be assessed at the rate of less than or equal to the IRS standard mileage rate. Mileage will be charged on all trips.

**Minimum unit fee:** Container, Rail & Truck sampling request must average a minimum of 2 units per hour otherwise an additional \$10.00 will be applied per hour.

(Hourly and mileage fees will be in addition to the unit fee unless stated otherwise.)

**Railcar/Container rate:** \$16.73 per unit

**Truck rate:** \$13.40 per unit

**Aflatoxin:** \$31.00 per test

**Vomitoxin:** \$31.00 per test
