## OFFICIAL FEE SCHEDULE

**EFFECTIVE DATE:** Effective October 6, 2017. This fee schedule supersedes all other fee schedules issued by State Grain Inspection. The fees set forth in this schedule relate to sampling, inspection, weighing and other official services and certification performed by State Grain Inspection under the United States Grain Standards Act. Federal Grain Inspection must approve all fees for official services and official agencies will assess only those fees appearing on their current approved fee schedule. The FGIS user fees have been suspended for a indefinite time and are reflected.

**MAIN OFFICE HOURS:** Monday through Friday 7:00 a.m. through 3:30 p.m. except holidays.

**OVERTIME HOURS:** Charges are at time and one half for services, Monday through Friday, before 6:00 AM., after 5:00 PM., after 8.0 hours per day, and Saturdays. Sundays and Holidays are charged at double the regular rate.

**HOURLY RATES:**

Regular - Sampler	\$ 18.00
- Inspector	\$ 26.00
Overtime - Sampler	\$ 27.00
- Inspector	\$ 39.00

Additional Labor: \$22.00 per hour.

All rates are per hour and assessed in one-half hour increments. A minimum of one hour for service will be charged at the applicable hourly rate during regular hours. A minimum of three hours applies to hours outside regular service hours. Hourly rates will be charged, at one and one-half times the applicable hourly rate for sampling if the following minimums are not met: an average of: 3 railcars per hour or 2 containers per hour.

**Minimum Hourly call out rates:** Minimum 2 hours per person at applicable rate will apply for under 4 hour notice of cancellation or request. State Grain Inspections reserves the right to determine the number and type of personnel to properly service the customer.

**Call Charges:** Call out, on call (Personnel are off site waiting to report for duty.), or back to work will be assessed a 4- hour minimum per person at the applicable hourly rate.



**HOLIDAYS:** New Year’s Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Christmas Day.

**MILEAGE FEES:** The Internal Revenue Service standard rate will be assessed for actual miles traveled to perform services that are more than 5 miles from the Savage office (or the nearest full time staffed office). Mileage rate will change when IRS standard rate changes.

Contract services available upon request priced according to this fee schedule.

Official Commercial Inspection services are available and negotiated on a case by case basis.

All other official services not covered in this fee schedule will be charged at the appropriate hourly rate.

New Years Day, Memorial Day, Independence Day(July 4<sup>th</sup>), Labor Day, Thanksgiving Day and Christmas Day.

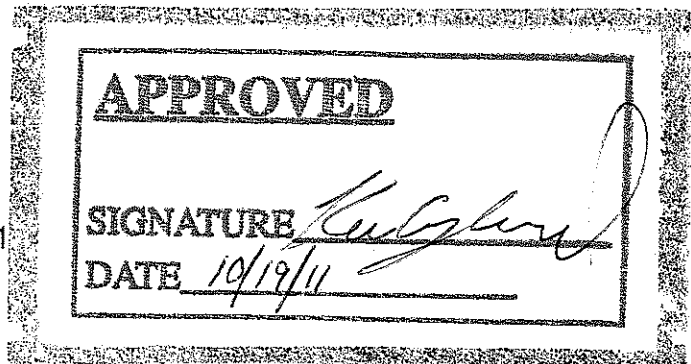

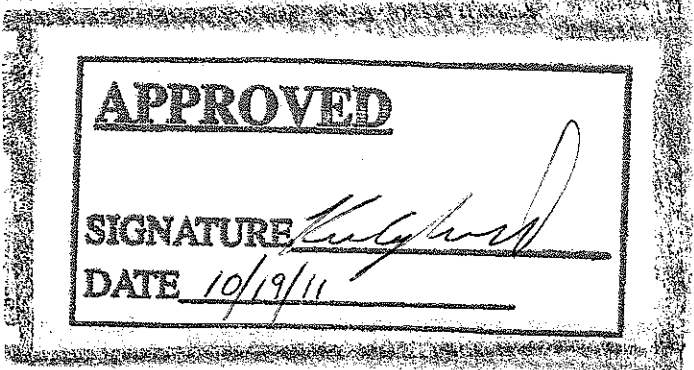
